**Rules and Regulations**  
**Yard, Garage, Porch and Barn Sale License**

1. Any property owner or occupants of said property who wishes to have a yard, garage, porch or barn sale must obtain a permit from the Board of Selectmen under Chapter 6 of the General Bylaws of the Town.
2. Not more than 2 (two) yard, garage, porch or barn sales shall be held by any property owner or occupant of said property within one-year period.
3. The Board of Selectmen may grant more than 2 (two) permits per year to a religious, educational or other charitable organization.
4. Only articles and items owned by the property owner or occupant shall be sold at the yard, garage, porch or barn sale, unless in the judgment of the Board, the sole intent of the sale is to benefit a charitable organization located in the Town of Milton.
5. Each permit granted by the Board of Selectmen shall not be for more than 2 (two) consecutive days of sale.
6. *Signs will be permitted only on private property. No signs will be permitted on Town streets, on poles, trees or sidewalks.* Signs may be erected no more than two days prior to the sale and must be removed no later than the day following the sale.
7. Display or sale of merchandise prior to 9:00 a.m. is prohibited.
