The undersigned owner authorizes the applicant to apply for the permit and the operator to undertake such work on the property of the owner, and also, for the duration of the construction, authorizes persons duly appointed by the municipality to enter upon the property to monitor and inspect the work for conformity with the conditions attached hereto and the laws and regulations covering such work.

The undersigned applicant, owner and operator agree jointly and severally to reimburse the municipality for any and all costs and expenses incurred by the municipality in connection with this permit and the work conducted thereunder, including but not limited to enforcing the requirements of state law and conditions of this permit, inspections made to assure compliance therewith, and measures taken by the municipality to protect the public where the applicant, owner or operator has failed to comply therewith including police details and other remedial measures deemed necessary by the municipality.

The undersigned applicant, owner and operator agree jointly and severally to defend, indemnify, and hold harmless the municipality and all of its agents and employees from any and all liability, causes of action, costs, and expenses resulting from or arising out of any injury, death, loss or damage to any person or property during the work conducted under this permit.
